### **Reimbursement**

All workshop participants are asked to make their individual travel arrangements and to keep all **original receipts** for reimbursement. Travel expenses are reimbursed according to the Bundesreisekostengesetz (German Travel Expenses Act) by the MPI. ### **Directions**

#### **Arriving by plane**

Follow the signs for public transport/regional trains. Before you get on the train, please purchase a ticket at the ticket machine (one way ticket to Frankfurt City costs 4.65 €). Take the train or subway to Frankfurt Hauptbahnhof/central railway station (approx. 15 min). For directions from the train station to the hotel, keep on reading “arriving by train”.

#### **Arriving by train**

Leave the station through the main gate and take tram line 17 direction Rebstockbad (please make sure you have a valid ticket, before you get on). Exit at the final station Rebstockbad (approx. 16 min). Walk straight towards Leonardo-Da-Vinci-Allee. The Ibis Hotel is located at Leonardo-Da-Vinci-Allee 40.

#### **Arriving by car**

The Hotel has a parking garage (parking fees will be covered). There is also limited parking space at the MPI. If you require parking close to the conference venue, please email Ms Rita Gommermann (gommermann@rg.mpg.de) **until 4 April** indicating your name and license plate. Please note that we will reimburse 20 cent per kilometer (max. 150 €).

The Hotel is a 15 min drive away from the MPI and about 4 km from the city center.
