The systematic issuance of decrees by the permanent cardinals' congregations of the Roman Curia undoubtedly marked an important turning point in the normative production of the Apostolic See, in the conduct of internal decision-making processes within the curia, in the definition of relations with local institutions and actors. Additionally, it contributed to the evolution of Canon Law in the early modern and contemporary age.

New research groups, recent scientific projects and publishing initiatives show the renewed interest in these topics in recent years. The idea of these workshops stems precisely from the desire for exchange and discussion among specialists in the history of various Roman congregations and their normative production through the issuance, publication, and use of decrees in the practice of administering justice.

Both workshops are also open to other research groups and scholars. However, given the specific nature of the topics and discussion, we encourage the participation of persons and groups actively involved in investigation related to the decrees of the Roman congregations and data modelling in the specific legal-historical context outlined above. # The decrees of the Roman congregations between past and future. State of the art and research perspectives

#### 22.04.2024

Turmcarrée, Bleichstraße 59, 15:00-19:00

Starting from an open discussion on the state of research on the decrees of the Roman congregations from the perspective of an archival and historiographical investigation, the seminar will first of all look at the decrees in the broader context of Canon Law, the normative production of the Apostolic See and secular law. The different types of decrees issued in the course of time will therefore be explored, and the procedures for the formulation and approval of decrees will be analysed, with an attempt to identify recurrent practices among the different congregations and patterns in their formulation. The media used for the dissemination of decrees and the role of manuscript and printed compilations of decrees in the context of the administration of justice will also be discussed. Finally, the weight and role of the decrees of Roman congregations in local contexts will be examined and the main recipients of the decrees will be identified, analysing the actors and institutions involved. The meeting will end with an interactive activity to explore together the structure of the decrees from an archival and legal-historical perspective. This activity is preparatory to the seminar on the following day dedicated to the comparison and discussion of the data models of the participating research groups and scholars.

# The decrees of the Roman congregations from the archives to the web. Experiments in data modelling with a view to interoperability

#### 23.04.2024

The seminar focuses on the application of innovative approaches for modelling data on decrees of Roman congregations, with the aim of improving interoperability between research projects. We will explore the challenges and opportunities in modelling decrees data, discussing how we can accurately and comprehensively represent such data in a conceptual model. We will also examine strategies for functionally comparing the different data models used for decrees of Roman congregations, exploring tools and resources that can facilitate this comparison. We will also present approaches for designing interoperable tools that enable smooth transitions from one project to another and link decrees to other decrees or related events. Finally, we will address the challenge of linguistic plurality in the sources and our digital tools, exploring how to effectively manage this linguistic diversity to ensure accurate data accessibility and interpretation. The aim of the seminar is also providing a solid basis for future developments and interdisciplinary collaborations in historical and digital research.
