Project of the Month



Colonial Concessions in Tunisia Under the French Rule: 1860 and 1900

At the core of property and sovereignty quarrels as well as in debates on land reform and the history of international economic law, this study examines concessions through a legal historical lens. In Tunisia, the narrative of concessions is at the intersection of public land reforms and an extraterritorial governance which was namely the protectorate embedded in a foreign investments policy on the markets of the periphery. The reservoir of public land grantable depended on public land reforms undertaken, and these were exclusively granted to foreign corporations. This process led not only to the expansion of territoriality but also to the control of the colonial state over land and its resources. The project shows the centrality of concessions to the economic domination that was characteristic of the French administration extraterritorial policy in Tunisia. This stood in

stark opposition to the neighboring country Algeria, where an initial straightforward conquest of sovereignty took place.



Novedades en la serie “Filosofía Política y Teoría del Derecho de la Edad Media y la Edad Moderna” (PPR)







cooperation between the different units and getting to know one another better.


Our department presented its work with Digital Humanities (DH). Concentrating on three overarching aspects—accessibility, usability and sustainability—four major DH projects in the department (“[The School of Salamanca](#)”, “[SCC Explorer](#)”, “[Historical Dictionary of Canon Law](#)” and “[Non-State Law of Economy](#)”) reflected on what Digital Humanities mean to them, the impact on their research and what it entails in practice to combine legal history with digital methods. All four emphasised the importance of teamwork and institutional support for the success of such endeavours.

Reconsidering 'Law' in Traditional China and Beyond: A Shift of Approach from Judicature to Governance

Max Planck Lecture in Legal History and Legal Theory



La conferencia del profesor Wang ofreció una perspectiva sugerente sobre las concepciones del derecho en la China imperial, centrada en la gobernanza local y las prácticas normativas cotidianas. A partir del análisis de regulaciones locales, mostró que el orden social se basaba en normas de comportamiento internalizadas (law in mind) y en formas de resolución de conflictos más morales y comunicativas que jurídicas en sentido formal. Esta visión cuestiona la idea de que el derecho moderno, estatalizado y profesionalizado, constituye un modelo universal. En la China imperial, las normas eran generadas y aplicadas localmente, lo que pone de relieve un tipo de autoridad construida desde lo comunitario. Al comparar este modelo con el sistema de jueces de paz en la Inglaterra de la temprana Edad Moderna, Wang evidenció que también en Europa existieron formas de justicia local en las que las élites colaboraban con el poder central. Según él, esta configuración sigue resonando en la cultura jurídica contemporánea china y constituye un ejemplo de saberes normativos comunitarios que pueden ser comparados con otras experiencias jurídico-sociales.

Acquisitions on Amazonia

Indigenous legal histories in Amazonia reveal a world of entangled normativities shaped by native customs, imperial laws, and missionary strategies. The library of the Max Planck Institute offers a rich collection for exploring governance over Indigenous populations from the sixteenth century onward. Its holdings comprise core legal history texts, colonial treatises, missionary writings, and interdisciplinary works addressing justice in relation to land, property, gender, race, and mestizaje. This diversity helps reconceptualize Amazonia not as an imperial periphery but as a space of active legal production where Indigenous, royal, and missionary knowledge intersected, clashed and reconfigured justice, subjection, and autonomy. By foregrounding Indigenous voices, practices, and strategies of legal intelligibility, the sources provided by the library challenge Eurocentric narratives and become a key element for building a connected, comparative legal history rooted in Amazonian experiences.


