



Project of the Month



Indigenous knowledge: making captivity, slavery and freedom intelligible in Portuguese Amazonia (17th–18th centuries)

A Amazônia e seus povos indígenas são cruciais para compreender os regimes jurídicos globais de escravização e liberdade. Este projeto investiga como, nos séculos XVII e XVIII, indígenas da Amazônia portuguesa participaram ativamente da construção dos regimes normativos coloniais. Ao tornarem inteligíveis categorias como cativo e liberdade, mobilizaram memórias, práticas consuetudinárias e estruturas de parentesco como formas legítimas de saber jurídico. Longe de serem receptores passivos das leis, atuaram -por meio de

procuradores- como tradutores e elaboraram concepções próprias sobre o direito, especialmente nas Juntas das Missões. A pesquisa valoriza a memória indígena como normatividade viva, articulando identidade, proteção e liberdade. Com base em petições, textos normativos e correspondência missionária, revela-se como os pleiteantes performavam juridicamente a identidade indígena, contestando e readaptando o universo normativo colonial. O projeto contribui para a história global do direito e para o reconhecimento da agência indígena nos processos de produção e inteligibilidade jurídica.


História do Direito Latino-americano em Perspectiva Global

Este volume resulta de um projeto coletivo de historiadores da América Latina, Europa e EUA, que buscam analisar a história do direito a partir das experiências comuns das sociedades latino-americanas, inseridas em uma perspectiva global. Abrangendo desde as comunidades indígenas autônomas (incluindo experiências anteriores ao século XVI) até os desafios contemporâneos do direito estatal, o livro percorre os períodos da colonização, das independências, das revoluções e da construção e consolidação dos Estados. Examina o direito em diversos contextos históricos, explorando fontes jurídicas variadas e enfatizando sua configuração enquanto prática social.

Temas como leis indígenas, influências religiosas, experimentações pós-independência, codificações nacionais, direitos humanos, ditaduras, justiça transicional e pluralismo jurídico são abordados, destacando conexões transnacionais. A obra propõe uma metodologia inovadora, priorizando perguntas sobre respostas, processos sobre resultados e contextos sobre soluções. Questiona onde, como e por que o direito se materializa, identifica seus protagonistas e cenários, e o insere em dinâmicas sociais, políticas, culturais e econômicas.

Originalmente escrito em inglês intitulado “The Cambridge History of Latin American Law in Global Perspective” (CUP, 2024) e traduzido para o português por Gustavo Silveira Siqueira e Júlia Muinhos.

Knowledge of Normativity and Printing Technologies. Networks, Authenticity, Typographic Devices

Workshop of Max Planck Partner Group

The 2nd meeting of the Max Planck Partner Group "[The Production of Normativity and the Early Modern Book](#)

[Trade](#)" took place at the University of Barcelona. At the workshop, group members focused particularly on three topics: 1) "Spaces and Networks", examining the international exchange and circulation of people and normative books and the networks that made these circulations possible, 2) on the interplay between "Authenticity, Authorship and Authority" concerning normative books, and 3) on "Printing Technologies and Typographic Devices".

The group examined these subjects by combining the questions and methods of legal history, book history and the history of knowledge in an interdisciplinary way. This approach highlighted the specific ways in which knowledge of normativity was produced in the Early Modern Period through an analysis of the materiality and sociality of law books— factors that, at that historical juncture, contributed to the emergence of the first truly global book market.

Between Norms and Culture: Colonial Governance and Translation of Knowledge of Normativity in Portuguese India

Workshop

Researchers from Brazil, India, Japan, Italy, Portugal, and Germany convened to reflect on the intersections of governance, normative regimes, cultural translation and knowledge of normativity in the early modern world, with a particular focus on Asia.

Presentations addressed the transformation of urban spaces, colonial encounters, religious practices, and processes of adaptation within legal and administrative settings. Among other topics, the participants discussed the emergence of new cultural landscapes shaped by shifting trade patterns and tensions between evangelization efforts and Inquisitorial control, especially in relation to indigenous communities.



These contributions revealed the complex interplay between power, knowledge, and culture, demonstrating how normative orders were continually produced, contested, and negotiated across different imperial and local contexts. Law and governance were not simply imposed, but emerged through processes of negotiation, adaptation, and practical necessity.

Impreso en Lyon en 1651, el tratado [De Iustitia et Ivre](#) de Fernando de Castro Palao, estudia con prolijidad la virtud cardinal de la justicia en general y la justicia conmutativa en particular. En concreto analiza los pactos y contratos, la promesa y la donación liberal, el comodato y el depósito, el préstamo y la usura, la compra y venta, los censos, cambios, las sociedades –en especial la dote de la sociedad conyugal–, así como la enfiteusis y el feudo; además aborda escuetamente el resto de virtudes: prudencia, fortaleza y templanza. Las decisiones del teólogo moral jesuita y calificador de la Santa Inquisición vinculado a la Universidad de Salamanca fueron enormemente apreciadas por su enfoque de probabilismo

moderado.
